#### **CORE SERVICES**

## Annual Essential Safety Measure Report (AESMR)

Buildings in Victoria must comply with the 2018 Victorian Building Regulations. The building owner must provide an AESMR, confirming that all essential safety measures (ESM) have been maintained in accordance with the Occupancy Permit requirements. Q Compliance will visit your site, perform an in depth ESM audit, help you to rectify any defects, and then issue/sign an AESMR to confirm your building is compliant.

### **Fire Equipment Maintenance**

Fire equipment must be maintained in accordance with the buildings Occupancy Permit. Q Compliance will visit your site to service equipment in accordance with the Australian Standards to protect building assets and provide occupant safety in the event of an emergency.

## **Building Fire Integrity Inspection**

Buildings must be inspected annually to ensure that passive fire elements are installed and maintained. This includes fire protection at service penetrations, construction joints, building fire compartmentation, and fire resistance of building materials. Q Compliance will attend your site, conduct the inspection, and identify any non-compliance.
